

prepared and committed families for the thousands of teenagers in foster care. Many of these young people are less likely to be adopted, often because of their age, and will too often age out of the system without a stable support system. Securing lifelong connections for these teens, legally and emotionally, is an urgent need and critical component of their future achievement and overall wellbeing. Because the importance of adopting teens has been the focus of National Adoption Month for the past two years, the Children's Bureau website

has highlighted a new aspect of this vital work. For 2017, it features valuable resources to help child welfare agencies build an effective response system, which is a vital component to ensure a strong pool of adoptive families who are equipped and prepared to parent teenagers. ## ADOPTEES BIRTHRIGHT ACT UPDATE

Adult adoptees continue to request and receive their "non certified" Original Birth Certificates (OBC) via the Adoptees Birthright Act that was implemented on January 1, 2017. According to NJ Vital Statistics as of early November, over 4,000 adult adoptees have requested their OBC's

and over 3,900 have received them. There have been rare instances where Vital Statistics did not have the OBC if the adoptee was born outside of NJ although the adoption was finalized in NJ. As of November 3rd, Pennsylvania adult adoptees born in PA may now request their non-certified OBC.

# ANGELS IN ADOPTION AWARDS

NEW JERSEY "ANGELS" RECOGNIZED

The Congressional Coalition on Adoption (CCAI's) Angels in Adoption® Program honors a wide spectrum of individuals and organizations making extraordinary contributions in adoption, permanency and child welfare. Each year, the Angels in Adoption® awardees travel to Washington, D.C., to celebrate both their hard work and dedication to the issues and participate in special events designed to engage them in using their personal experience to effect change on behalf of children in need of families. Since the program's inception in 1999, over 2,500 Angels have received this honor. Here are our NJ Angels:

# <u>Liza Kirschenbaum</u> Recommended by Senator Cory Booker

Liza Kirschenbaum started an organization with no resources or infrastructure and grew it into a fully functioning, statewide operation serving thousands of formerly abused and neglected children—2,236 of whom have been adopted over the last ten years into safe homes with loving families. Before Liza laid the framework for the establishment of Court Appointed Special Advocates for Children

(CASA of NJ) in January of 2000, only two local nonprofit CASA programs operated in New Jersey. Through Liza's work at a northern New Jersey law firm, she realized that children removed for abuse and/ or neglect needed better legal representation. At the time, law quardians were only statutorily required to stay on a case until the termination of parental rights phase. Liza began training attorneys to provide pro bono representation for a child from the child's removal from home all the way to the child's placement in a permanent home. In that capacity, Liza learned about CASA and the need for lay advocacy in both the court and the community. After participating on a steering committee to develop CASA of NJ, Liza left private practice (taking a 70% pay cut) to start CASA of NJ, with the vision of establishing a CASA program in every county and bringing CASA advocacy to every child who needed it. Through her work, and through years of infrastructure development, fundraising, and productive partnerships, a CASA program was established in every judicial vicinage by 2009. By 2011, CASA programs existed in every county of the state.

### Recommended by Senator Robert Menendez

Debra E. Guston has thirty years of experience in handling adoption cases in New Jersey. She has represented over 1,000 New Jersey adoptive families in finalizing their adoptions and has represented scores of birth parents as they made the difficult and courageous decision to place children for adoption. Ms. Guston worked with Angel William S. Singer, Esq., to develop the legal framework for adoptions by same-sex couples in New Jersey before New Jersey's courts recognized that the state's statutes authorized such adoptions. In May 2017, Ms. Guston assumed the post of President of the Academy of Adoption & Assisted Reproduction Attorneys, an international, credentialed association of over 465 attorneys worldwide with significant expertise in adoption and assisted reproduction law. Ms. Guston is the Chair of the New Jersey State Bar Association's Family Law Section Adoption Sub-Committee and is the lead coordinator of annual adoption continuing legal education classes for the New Jersey Institute of Continuing Legal Education. She is also the current President of the Board of Trustees of the

David C. Baker served in the Vietnam War in an Army Canine Unit and later returned to Vietnam to help children there. He is currently working with a small temple in Vietnam



He cuts lawns in order to raise money for his projects and contributes money from his personal income (VA Pension). His wife's family in Nha Trang, Vietnam, assists in

this work as well. David started a program that pays \$100 to anyone who brings in a baby who has been found abandoned. Beyond his work specifically with orphans, David has promoted child welfare in the region by raising money to support daycares and children's clinics.





# NATALIE'S LIBRARY CORNER

Welcome to Natalie's Library Corner!

Now that the Adoptees' Birthright Act has passed in New Jersey, many adult adoptees have successfully received copies of their original birth certificates. Having this bit of their history is so momentous, yet often brings more questions and a more immediate need to continue their search. The search and reunion process in adoption brings about an array of feelings and emotions for all members of the adoption triad. These books highlight the process and provide readers with insight on the process, emotions, and potential outcomes.

Reunited: An Investigative Genealogist Unlocks Some of Life's Greatest Family Mysteries by Pamela Slaton is a collection of true stories detailing some of Ms. Slaton's most prevalent cases. Ms. Slaton is an investigative genealogist, who is herself an adult adoptee. Her successes have been chronicled on the O Network television show, Searching For. Ms. Slaton resides and works in New Jersey. Her book begins with her own search and

difficult reunion and continues with her journey to help others. She states, "These are the stories of adoptees and their search for themselves. The impulse to search is about the basic human need to connect with those who gave you life. At a minimum it offers closure. It fills in the missing pages in the story of our lives . . . beyond that, the search teaches us something profound about humanity and blood ties that bind despite decades of separation."

Finding Family: My Search for Roots and the Secrets in My DNA by Richard Hill is an autobiography detailing the author's lifetime search for his birth family. Able to piece together much of his life story through his own detective work, it isn't until he utilizes DNA testing that he is able to put all the pieces together. Mr. Hill's story is suspenseful and fascinating. The final section on DNA brings to light an understanding of how DNA truly works in the search process.

A Single Square Picture: A Korean Adoptees Search for Her Roots by Katy Robinson is the author's quest to find her birth family in South Korea.

Adopted at the age of seven, Ms. Robinson has some memories of her birth mother and a single photo taken the day she left South Korea. She returns to South Korea as an adult and begins a search. She stated, "I wanted once and for all, to piece together the two halves of myself and create one continuous story that was my life - something that I assumed came naturally to everyone else not adopted". During her first trip she finds her birth father and a connection to her past. She returns again for a year filled with cultural understanding, more birth family contact, and a better understanding of who she was, and who she has become.

It has been medically assessed that he is unable to hear; however his caregivers sense a reaction to some sounds. Josiah enjoys community outings to the barber, to church services and his personal favorite, sitting in a Walmart shopping cart.



Mealani Born 2/2012

Mealani is a stunning girl whose winning personality and expressive eyes captivate everybody she meets. A lover of toys and cartoons, she can frequently be found playing with her Barbie dolls or stuffed animals. Mealani is an active and motivated

student who loves school and interactive teaching toys. A quick learner, she is learning to use sign language to communicate and is asserting her independence by propelling herself in her wheelchair without assistance.

Mealani is diagnosed with respiratory disease and a swallowing delay. She requires a feeding and breathing tube, but she is making great progress with regard to breathing on her own and staff is hopeful that she will eventually no longer need the breathing tube.

## **A**DOPTION **T**AX **C**REDIT

Tax season is right around the corner. Do you know about the Adoption Tax Credit? This federal tax credit can be claimed if you adopted a child from foster care, private adoption in the United States, or an International adoption, as long as the child was under age 18 at the time of adoption. You also qualify if you adopted a relative's child, but not for a step-parent adoption. The tax credit is also available for expenses incurred during a failed adoption in the United States and for a nonfinalized adoption in the United States. A tax credit is better than a tax deduction. as it is subtracted from the amount you owe on your tax-

How much you will be

able to use will depend on your income and tax situation. If your adjusted gross income is below \$241,920 you



may be eligible to receive either the full credit or partial credit. The full credit is \$13,570 per child. If you adopted from foster care and receive a subsidy, your child, according to tax laws, is considered a special needs adoption. For a special needs adoption, you can claim the federal tax credit even if you had no adoption expenses. For all other adoptions, you can only receive credit for qualifying

adoption expenses (these can include attorney's fees, agency fees, homestudy costs, court costs, travel, and more). For more information on the tax credit, be sure to check out NACAC (North American Council on Adoptable Children's website at www.nacac.org/help/adoption-tax-credit/.
