

This year's theme is "Small Steps Open Doors." Pursuing permanency for teens can be challenging, but small steps along the way can make all the difference. Taking the time to talk with and listen to youth can help earn their trust and help engage in their own permanency planning. It

can also create an environment where youth can be honest and ask questions. Youth are the experts of their own lives. It is best to let them partner in their permanency planning and make decisions about their lives.

Securing legal and lifelong connections for teens in foster care, is a critical component in determining their future achievement, health, and well-being.

In 1976, the governor of Massachusetts first proclaimed Adoption Week and, later that year, President Gerald Ford made it official nationally. The number of States proclaiming the observance of Adoption Week in November grew, and in 1990. National Adoption Week became National Adoption Awareness Month.

#### ORIGINAL BIRTH CERTIFICATE UPDATE

In January 2023, the Adoptees Birthright Act will celebrate six years since its implementation. This Act allows adult adoptees, born and/or adopted in New Jersey, to request an uncertified copy of their Original Birth Certificate (OBC) from the NJ Office of Vital Statistics. The response from its inception has been very positive with over 10,500 requests being completed to date.

#### EXPANDED CHILD TAX CREDIT

Families have until November 15, 2022 to claim the 2021 Expanded Child Tax Credit, through the simplified filing portal, GetCTC.org. This portal makes it easy for families to claim this money online on their own. While families can continue to claim the CTC after November 15th, they'll need to file full tax returns to do so. While the CTC has existed for over two decades, it was significantly expanded in 2021 and has helped families with the cost of raising children.

According to the GetCTC.org website, families may receive up to \$3,600 per child under the age of six (6) and \$3,000 per child ages 6-17. The credit is smaller for single parents earning over \$75,000 and married couples earning over \$150,000. If you earn less than \$240,000 as a parent or \$440,000 as a married couple, you can still receive a portion of the CTC.

In addition, families should be eligible for the full CTC payments even if they earn very little or no money and even if they do not usually file taxes. Children should quality if they have lived with you for at least half of the year of 2021 (six months and a day, does not need to be consecutive), they were under 18 at the end of 2021, and not born in 2022. Children must have a Social Security Number (SSN), while parents can have an Individual TaxPayer ID number (ITIN) or a Social Security number, along with other qualifications. See the Frequently Asked Questions (FAQ's) website at the end of this article.\*

If you received any monthly Advanced Child Tax Credit payments in 2021, you will need to file a 2021 tax return to receive the second

half of your money. The rest of your Child Tax Credit will be issued in one payment.

If you have not received any Child Tax Credit payments yet, you can file the simplified taxes now to get the whole credit. The portal makes it relatively easy for families to claim this money online on their own. While families can continue to the CTC claim after November 15th, they'll need to file full tax returns to do so.

## NATALIE'S LIBRARY CORNER

Welcome to Natalie's Library Corner!

National Adoption Month is a great time to add new books to your child's library! Here are a few of our new favorites!

The ABCs of Adoption:

**Kid Conversations about Adoption** bу Raquel McCloud and illustrated by Taylan McCloud is an exceptional new book for adoption library. The ABCs of Adoption is written from personal experience by an adoptee, birth mom, and adoptive mom. The book is illustrated by the adoptee's 12year-old daughter. This book tackles the complex fact that every adoption and every adoptees' experience is unique and different in the simplest of ways, with beautiful drawinas. With a page for every letter of the alphabet, the author touches on important definitions related to adoption, foster care, and kinship care. The author's words allow the young reader to hear and understand the terminology, but in a way, that validates differences. example, for the letter "P," the author talks about the significance of photos by writing, "Photos are a special way to save mem-Some adoptees ories. have photos of their birthfamily and some don't." Another example is with the letter "Q" for questions. The author inscribes, "Adoptees may have lots

of questions about their story and that is normal. Sometimes your daddy or mama will have the answers and sometimes they won't, but you should always feel safe to ask about your story." This book is all-inclusive as it international mentions adoption, open adoption, foster care adoption, newborn adoption, and kinship adoption. The author concludes with the letter "Z" for "Zigs and Zags": "Zigs and Zags are when something doesn't follow straight line. Adoption is like that. There isn't just one kind of adoption story, one emotion, or one experience."

Another great new book for children is Adoption is **Both** by Elena S. Hall and illustrated by Lar Norris. Adoption is Both acknowledges that there is more than one way to think about adoption and that all feelings are valid. This simple and rhythmically narrated story begins with "Adoption is happy and adoption is sad. lt can make my heart hurt or make it feel glad." A simple character colored sometimes in pink and sometimes in blue shares their perspective on adop-The little character embraces their feelings and sings of pride in both the good and the bad; changing colors to match their Concluding with emotion. proclamation that "Adoption is both - pink and blue! Pink and Blue! Both are true." This book lends well to conversations

with young children about their own adoption story.

Yet another necessary addition to your library of children's books is What is **Adoption?** by Jeanette Yoffe and illustrated by Devika Joglekar. In this Yoffe book, Jeanette explains the realities of adoption in terminology that young children will understand. She begins by explaining, "Sometimes families just can't live together, so it is necessary to find another family who will love and take care of the children." This includes very real scenarios that answer "why" questions. The book explains the role of social workers, foster families, and judges in the adoption process and why things take so long. The next section explains the very real feelings a child will have in their new family including grief, guilt, and numbness. The author writes, "Big feelings will come and big feelings will go, like a great big wave so just go with the flow, don't push them away, make them your friend, so you can understand your grief and go play again." What is Adoption? concludes with wonderful statistics on adoption and a list of famous adoptees to allow the young reader to not feel alone.
